Program Overview

The Great Barrier Reef is the world's largest coral reef system with some of the richest biodiversity on the planet. It is recognised as one of the world's most iconic tourism experiences and continues to be Australia's greatest natural attraction.

The Great Barrier Reef offers a unique place-based educational opportunity for students to immerse themselves in an authentic live classroom and to learn more about the rich biodiversity of the reef.

The Queensland Government is investing \$1 million over three years in the Great Barrier Reef Education Experience Program to support Queensland schools to undertake place-based educational experiences in the Great Barrier Reef World Heritage Area.

Location



The Great Barrier Reef World Heritage Area's biological diversity is unmatched by any other World Heritage Area on the planet. It is recognised as one of the world's most iconic tourism experiences and continues to be Australia's greatest natural attraction.

The Great Barrier Reef extends from the top of Cape York in north-east Australia to just north of Bundaberg. There are approximately 70 Aboriginal and Torres Strait Islander Traditional Owner groups with authority for Sea Country management in the Great Barrier Reef Marine Park.

The Great Barrier Reef was declared a World Heritage Area in 1981 because of its 'outstanding universal value'. This recognised the Reef as being one of the most remarkable places on earth, as well as its global importance and its natural worth.



Aims and Objectives

The Great Barrier Reef Education Experience Program (the Program) aims to generate increased interest from schools to visit the Great Barrier Reef region through the delivery of place-based learning activities which meet the Australian and Queensland curriculum and support opportunities for students to participate in reef-related curriculum activities.

The Program is designed to:

- enable more students to experience the Great Barrier Reef through participation in school excursions across the region;
- facilitate more place-based learning activities in the Great Barrier Reef that are tailored to support student learning in line with the Australian and Queensland curriculum;
- support opportunities for students to participate in reef restoration and conservation activities;
- develop greater connections to reef systems and allow for more awareness and understanding of natural habitats and pressures facing the Great Barrier Reef;
- provide opportunities for tourism operators in the Great Barrier Reef to refresh and develop educational products and experiences;
- support the Great Barrier Reef tourism operators impacted by recent natural disasters and the COVID-19 pandemic; and
- stimulate new, sustainable market opportunities and subsequent tourism visitation into the Great Barrier Reef region, supporting economic growth, encouraging repeat visitation.

Timing

Schools can apply for the subsidy for eligible school excursions being undertaken from Term Three, 2021. The Program will run over a three-year period or until funding has been fully exhausted.

All travel needs to be completed by 5pm AEST 31 December 2024 or earlier if all available funding has been allocated.

Eligibility

Queensland Schools

The Program is available upon application to all primary and secondary Queensland schools, including schools of distance education, where students are participating in an eligible curriculum-related experience as part of their excursion. Schools must apply on behalf of their enrolled students participating in the excursion. Subsidy payments will not be provided to an individual student or their family and can only be passed on as savings on the cost of the excursion.

Reef Experiences

To claim the subsidy, a school's excursion itinerary must include at least one curriculum-related reef experience, facilitated through a commercial reef tourism operator registered with the program and delivered within the Great Barrier Reef World Heritage Area boundaries.

Eligible reef education activities will need to align with Australian and Queensland curriculum and may include:

- On-water experiences (e.g., glass bottom boat, whale watching, outer reef pontoon activities, canoeing or sea kayaking, and tall ship or maxi yacht sailing adventures)
- In-water experiences (e.g., snorkelling, semi-submersible activities, scuba and helmet diving)
- Great Barrier Reef on-island experiences (e.g., camping, visiting a turtle rehabilitation centre or research station, doing a nature discovery walk)
- Great Barrier Reef cultural experiences (e.g., Indigenous Sea Rangers and reef education tours; cultural tour and reef education on Great Barrier Reef Sea Country).

The subsidy cannot be claimed <u>solely</u> on expenditure for air travel, accommodation, fuel for schools or privately owned boats, meals and/or mainland reef experiences (e.g., visiting an aquarium or wildlife rehabilitation centre).

Planning Curriculum Activities

Collaborative planning of curriculum activities is strongly encouraged. Teachers and adult supervisors involved in the activity should use the Curriculum Activity Risk Assessment (CARA) Planner (DOC, 423KB) during the planning phase of an experience. This planner provides support in identifying hazards, assessing the risks, determining an inherent risk level, deciding on control measures and documenting the risk assessment for the experience.

To assist Queensland Schools to conduct and prepare risk assessments, CARA guidelines are available for a wide range of activities that may be part of delivering the curriculum in Prep to Year 12.

The guidelines are developed to align with policies, regulations and guidelines of Queensland and Australian Governments, and the standards and processes of peak bodies within Australia. In addition, they are regularly reviewed and undergo a comprehensive consultation process with schools and regions.

Schools must also consider the latest COVID-19 advice prior to undertaking any curriculum experience.



Commercial Reef Operators

Schools (or their travel intermediary) are responsible for the selection of a commercial reef tourism operator for inclusion in the itinerary which meets the school's educational, accessibility and safety requirements.

Commercial Reef Tourism Operators must satisfy the following requirements:

- <u>COVID safe plan</u> in place;
- <u>Blue card</u> for all staff that will be engaging with students;
- Capacity to facilitate an eligible reef experience that aligns to the Australian and Queensland School curriculum;
- Have a Great Barrier Reef Marine Park Authority <u>permit</u> with permission to conduct a tourist program within the Great Barrier Reef World Heritage Area boundaries;
- Capacity to provide the risk assessment documentation and safety advice required by schools for the activities being undertaken; and
- Be recognised by the Great Barrier Reef Marine Park Authority as a High Standard Tourism Operator and/or be recognised by Tourism and Events Queensland as offering a Best of Queensland experience; or be a marine research provider.

Commercial reef tourism operators are invited to submit an Expression of Interest form to the Department of Tourism, Innovation and Sport (the Department) confirming that they meet the above requirements. These operators will be listed on the Program website and schools will be required to demonstrate that their excursion itinerary includes one of the listed commercial reef operators.

Commercial reef tourism operators are welcome to submit an Expression of Interest at any time over the threeyear program period at <u>https://www.dtis.qld.gov.au/our-work/experience-programs-education/great-barrier-reef/apply</u>.

Travel Intermediaries

Schools can engage a travel agent, edu-travel company, transport provider or booking agency to assist with the development of their school excursion itinerary.


Applications for the subsidy can only be submitted by the school undertaking the excursion and travel intermediaries are not permitted to apply on behalf of the school.



Application Process

Applications opened on 15 June 2021 and schools can apply here.

Schools will need to submit their application at least four weeks prior to the planned departure date of their school excursion. All applications will be processed in order of receipt and schools are encouraged to submit applications as early as possible.

Subsidy Payments and Rates

Payments

Applications for the subsidy can only be submitted by Queensland Schools and will not be accepted from individual students, parents, or travel intermediaries.

The subsidy will be paid directly to schools after their planned experience or itinerary has been assessed as meeting the eligibility requirements for funding. No subsidy payment will be made for any travel or Great Barrier Reef education activities that are undertaken prior to approval of a school's itinerary.

The subsidy is calculated on a per student basis. Accompanying teachers and adults are not included when calculating the subsidy. A student is only eligible for the rebate once and the school is responsible for ensuring that each student for whom the funding is claimed has not, to the best of the school's knowledge, received the subsidy previously.

For overnight itineraries, 50 per cent of the subsidy will be paid upon approval of the school's application and the remaining 50 per cent will be paid upon receipt of the completed survey after the excursion.

For day trips, the subsidy will be paid upon completion of the approved day trip, noting that approval must be obtained before the day trip is undertaken.

Schools are to acknowledge the subsidy provided by the Department of Tourism, Innovation and Sport in a school newsletter upon the return from the excursion.

Rates

The subsidy is not intended to cover all costs of the planned activities or itinerary. Funds are allocated to schools on a per-student basis, at rates corresponding to the round-trip distance travelled from the school as per the subsidy table below.

Day trip	
Distance not applicable	Subsidy value
Flat rate	\$40

Overnight itinerary	
Total distance travelled (round trip) - sliding scale	Subsidy value
Level 1 - up to 499km	\$55
Level 2 – 500km – 999km	\$85
Level 3 – 1000km – 1499km	\$115
Level 4 – 1500km plus	\$150



Where the school excursion itinerary includes both an Outback Queensland and Great Barrier Reef education experience, the school will be eligible to apply for subsidies under both programs (i.e., the Great Barrier Reef Education Experience Program and the Outback Queensland Education Experience Program).

Goods and Services Tax (GST)

The subsidy amounts referenced in this guideline are GST exclusive.

Where a school is registered for GST:

- The subsidy received will consist of the agreed subsidy plus GST.
- The school will be required to provide a Tax Invoice that shows its Australian Business Number (ABN), the agreed subsidy, and the relevant GST amount.

Where a school is not registered for GST:

- The subsidy received will consist of the agreed subsidy and no GST.
- The school will be required to provide an invoice or receipt that shows its ABN and the agreed subsidy amount. As no GST has been received/paid this invoice/receipt will not include GST.

Cancellations

Reef Tourism Operators reserve the right, at any time to cancel any curriculum-related activities. Activities can be cancelled or have scheduled changes (with or without notice) for a variety of reasons, including, but not limited to, bad weather conditions, sea conditions, and operational or technical disruptions.

Reef Tourism Operators may place a school's booking on hold for another time, or reschedule the trip at the time of cancellation, or provide a full refund. However, it is the school's responsibility to review and adhere to the cancellation policy of the engaged operator.

For daytrips, regardless of the situation, the subsidy is only payable after the eligible curriculum-related experience has been undertaken and a copy of the paid invoice or receipt has been submitted for reimbursement.

For an overnight excursion where the first payment of the subsidy has been made and travel has been undertaken, but the eligible reef related experience could not proceed due to, but not limited to, bad weather conditions, sea conditions or operational disruptions, the second part of the subsidy is still payable. The payment will only be made where evidence (e.g., cancelation advice, refund documentation) is provided to demonstrate that the experience could not be undertaken at another suitable time during the excursion.

Where an entire overnight excursion itinerary has been cancelled (and not rescheduled) and the school has received the first payment of the subsidy, this amount will need to be refunded within five working days.



Privacy and Indemnity

Privacy statement

The Queensland Government collects and collates information from the application form to evaluate applications for the Program. Only authorised departmental officers and approved subsidy assessors have access to this information for the purpose of assessing the application for funding. Applicants should note that broad details of successful applications, agreed outcomes, progress and the level of subsidy provided may be published by the Queensland Government. Some information may be used to promote the Program. Personal information regarding an applicant and other person's will not be disclosed to any other third party without their consent, unless authorised or required by law or for the purposes of the *Information Privacy Act 2009*. For audit purposes, the Queensland Government is required to retain the applications and other supplied support material. The provisions of the *Right to Information Act 2009* and *Information Privacy Act 2009* apply to documents in the possession of the Queensland Government.

The terms and conditions of your chosen Commercial Reef Operator or any other provider engaged during the excursion, including any cancellation policies and fees, apply to your booking. The Department is not party to your booking agreement with the commercial reef operator or any other operator or provider engaged during the excursion and assumes no liability under the agreement.

Definitions

CARA	An acronym for Curriculum Activity Risk Assessment which set the minimum safety standards for a variety of common curriculum activities.
Curriculum activity	Any activity conducted with students to support the delivery of the Australian and Queensland curriculum from Prep to Year 12.
Excursion	A well-planned curriculum-related activity that is conducted outside of the school grounds that aims to maximise students' learning experiences.
High Standard Tourism Operator	The Program is run by the Great Barrier Reef Marine Park Authority to recognise tourism operators who operate in an ecologically sustainable manner, delivering high quality reef experiences. Operators are independently certified by environmental certification schemes, Ecotourism Australia and Earth Check, as part of the requirements to be a part of the High Standard Tourism Operator Program.
Best of Queensland Experience	Best of Queensland Experiences are those who exceed consumer expectations, bring the Queensland story to life and consistently deliver an exceptional customer experience.
	The Program is based on an independent set of criteria that incorporates online customer reviews, responds to consumer expectations and reflects industry best practice. Experiences are assessed annually.
	The Program is led by Tourism and Events Queensland and has been developed in partnership with the state's Regional Tourism Organisations, the Queensland Tourism Industry Council and the Department of Tourism, Innovation and Sport.
